

Competition Terms & Conditions

Entry

- 1. Silentnight Group Limited ("Silentnight") (Company number: 7525259 and whose registered office is at Long Ing Business Park, Long Ing Lane, Barnoldswick, Lancashire, BB18 6BJ) is the promoter of the free order competition ("Competition").
- 2. The Competition will open on [12:00am] BST on 28th March and will close at 12:00pm] BST on 26th April. Any entries received after the Closing Date will not be entered into the Competition.
- 3. By entering this Competition, you agree to be bound by these Terms & Conditions ("Conditions") and confirm that all information submitted is true, accurate and complete. Silentnight reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards Silentnight and the Competition.

Who Can Enter
